Successful International Enterprises and Overseas Talents Recruitment Activities

"The 2006 Career Expo for Overseas High-tech Talent of the Executive Yuan" started in September 2006. It aims at recruiting overseas high-tech professionals in the United States and Japan. The STSP Administration participated in the program.

During the trip, the STSP Administration promoted its industry clusters and the international collaborative network in key industries, such as the IC industry. To sum up the experience learned from the career expo, all worldwide successful science parks are equipped with excellent living conditions, well-established network infrastructure, convenient international transportation and abundant talented employees.

2006 Investment in Taiwan Conferences in the United States

In 2006, four Business and Employee Matching Conferences were held between September 7th and 17th in Silicon Valley, Los Angeles, Boston, and New York. Also, four Taiwan Investment Conferences were organized to introduce the investment environment and incentives offered In Taiwan to local enterprises.

Enterprises recruitment was added to the 2006 Career Expo for Overseas High-tech Talent. Potential investors are mostly biochemical and pharmacy companies whose main targets are the Taiwanese partners and government investments. In addition, software information companies are seeking opportunities to invest in Taiwan as well.

Owing to the great success of the previous recruitment mission in Japan in 2005, Meng-Fen Wu, Deputy Director-general of the STSP Administration, led another group and visited six reputed FPD equipment manufacturers and the FPD International Exhibition in Yokohama between October 16th and 21st 2006. In addition, the STSP Administration and Tainan County Government held a joint enterprises recruitment conference in Yokohama.

Trip across Europe - 2006 IASP World Conference and Enterprise Recruitment Mission

On June 4th 2006, Deputy Director-general of the STSP Administration, Meng-fen Wu, and Industrial Technology Research Institute members went to Europe to attend the IASP World Conference and recruit enterprises. The visiting mission set off for the Cambridge Science Park, Babraham Bioscience Technologies in U.K., Sophia Antipolis and Amadeus in France. Amadeus is the only company in the world providing a GDS (Global Distribution System) to airline companies. Besides, Adrian Scrase, Chief Technical Officer of European Telecommunications Standards Institute, gave the visiting mission an opportunity to enquire about the future plans of the telecommunications industry in KSP.

The visiting mission finally went to six counties in East England (Cambridgeshire, Norfolk, Suffolk, Essex, Hertfordshire, Bedfordshire), since they are areas with the fastest economic growth in English. The Cambridge Science Park is situated 55 miles northeast of London. Research is the priority in this area. The average research expense is three times that of the average expense in the entire U.K. and 91% of the companies have less than 20 employees.

Visit by Presidents

President Shui-bian Chen's Three Visits to the STSP

In 2006, President Shui-bian Chen visited the STSP three times to help balance development in both southern and northern Taiwan. On September 9th, President Chen was welcomed by the NSC Minister Chien-jen Chen and the STSP Administration Director-general Chun-wei Chen. The first visit was to inspect the STSP's present situation and development over the past nine years. After the presentation, President Chen inspected the STSP's infrastructure and the STSP Archaeology Gallery.

The second visit of President Chen was to inspect the KSP October 14th. He began the trip with a visit with Epoch Material Co., LTD. and then had a lunch

The third visit was arranged by the Ministry of Foreign Affairs. President Chen accompanied Sr. Elias Antonio Saca, President of the Republic of El Salvador on a visit to the STSP to review Taiwan's technological development and discuss the possibility of a technology exchange program. This visitation validated not only Taiwan's prospect to take root in Taiwan while reaching out to the world and to become a Green Silicon Island, but also the international competence of the STSP. When we share technological experience with Central and Southern America, our diplomatic mission would be accomplished.

Vice-President Hsiu-lien Lu is concerned about the STSP as much as President Chen. She visited the KSP with Technology Consultation Committee members on May 5th 2006. Fifteen high-tech manufacturing representatives, including Telecom Technology Center, the Association Industries in Science Parks and Chi Mei Optoelectronics, attended the conference to offer their opinions. The fact that Vice-President Lu discussed issues face to face with industry representatives shows the government's determination to balance technological development between the south and the north.
