The 2nd Government Service Quality Award Granted by the Executive Yuan

In order to reduce the management risk of Park enterprises, the STSP Administration, since the initial development stage, actively planned for a suitable disaster prevention and relief system. Joint responsive planning was completed in 2001 and a joint responsive organization and wireless system were established in 2003 for both domestic and international technologies and experiences. During 2005 to 2008, the "Expert Supporting System of Emergency Response Decision-making", based on integrated PDA, 3G cell phone, seismic monitoring, flood monitoring, and a GIS information system was developed. On June 30, 2010, the expert system based "STSP Integrated Disaster Risk Response System" received the "2nd Government Service Quality Award" of the Executive Yuan.

"2010 Sustainable Report Award of Taiwanese **Enterprise Received by STSP Environmental** White Paper

To ensure the sustainable development of the STSP, the STSP Administration compiled the "2009 STSP Environmental White Paper," the first one of its kind in Taiwan, which collected comprehensive environmental data of the STSP in 2009 for objective analysis of current status and managerial efficiency as well as sharing environmental experiences and results to realize the promises of the STSP in regards to environmental protection and sustainable development. The STSP Administration was the first governmental agency to participate in the ranking and on November 19, it received the special honor among non-profit organizations for "2010 Sustainable Report Award of Taiwanese Enterprises."

Receiving 2010 Award of Excellence in the Promotional Activities of Occupation Safety and Health Week by the CLA
