
Investment and Promotion

Investment Promotion in Spain

To strength the development of the green energy industrial cluster at the STSP, the STSP Administration during September 6 to 10 paid a series of visits to Spain. Investment recruitment activities were incorporated with the 25th EU PVSEC in Valencia, Spain. More than 900 enterprises participated in this exhibition and attracted more than 40,000 professional buyers. The STSP Administration set up a booth at the exhibition to introduce the excellent green investment environment at the STSP to the international community and assist Park enterprises in marketing themselves. The STSP's booth attracted many potential buyers and investors.

Promoting Biomedical Device Project in Japan
