- 4. STSPA website is obligate to protect every applicant's privacy; without your personal consent, or corresponding to the following conditions we will not amend or cancel any personal information and files.
 - A. Through legal way;
 - B. Protect or defend related personal right or title.

 - A. To coordinate judicial investigation;
